Ohio's College Credit Plus can help you earn college and high school credits at the same time by taking college courses from community colleges or universities. The purpose of this program is to promote rigorous academic pursuits and to provide a wide variety of options to college-ready students. Taking a college course from a public college or university is free. That means no cost to the family of public and private school students for tuition, books or fees. If you choose to attend a private college or university, you may have limited costs. Your high school may have an agreement with a local college for specific courses; however, you can choose to take College Credit Plus courses from any college that offers a course that would benefit your future. This could include online courses.

# **Eligibility Requirements for CCP Admission:**

- College ready 7th-12th graders
- Minimum 2.0 cumulative unweighted GPA
- At least a 17 composite ACT or SAT evidence based writing/reading and math combined score of at least 910
- College ready benchmark (ACT English 18, ACT Reading 22, ACT math 22)

# **Important Dates:**

- June ACT test (must register by May 8. <a href="https://www.act.org/">https://www.act.org/</a>)
- May 1, 2020 Deadline to submit annual Letter of Intent to Participate in CCP

- Public Safety We are partnered with Eastern Gateway Community College. Students in this
  lab will take an accuplacer test (September of Junior year) to see if they qualify for college credits
  with EGCC in the public safety pathway
- Biotechnology General Biology 1&2, Chemistry 1&2 are offered through YSU in our Biotechnology program. Students must have qualifying ACT scores and complete Letter of Intent. (only available Senior Year)

# Important things to know regarding CCP

- → CCP is free!
  - ◆ No application fee! High school pays for tuition and books
- → CCP courses are rigorous
- → You will be treated as a college student because you are a college student when taking CCP
- → The university communicates with you....not your parents or school counselor
- → Checking your email for information is important!
- → CCP grades will always be on your college transcript
- → Failing a CCP class can affect graduation
- → CCP classes can be used to meet High School Graduation Requirements
- → Students are allowed 30 credit hours per year of High School and College credit hours
  - ◆ Students who go over the 30 hours will be financially responsible for the course

College Credit Plus Application Process: Please follow these step by step directions for the different Universities that you would like to apply for CCP. If you would like to complete the application together through google hangouts, please email me (Valerie.Sullivan@MahoningCTC.com).

If you are going to complete these applications on your own please let me know once you have completed the application so I can contact the Universities and confirm it was completed correctly and they have all the information that is needed.

When completing your application you will need your social security number, a personal email account to use when completing the online applications (not your school email), and your home address.
